**Race1: INQUIRY:** #6 "Hesa Big Deal" (G.Dustin – 4<sup>th</sup> PL 5<sup>th</sup>) was inside 2 pylons into the turn after the ½ mile pole. #6 was lapped on at the finish by #5 "Muscle Up The Gold" (S.Wray – 5<sup>th</sup> PL 4<sup>th</sup>). Therefore #6 is placed (4<sup>th</sup> to 5<sup>th</sup>) for being inside two pylons and being lapped on at the finish. New order of finish: 2-1-3-5

**Race2:** Reviewed racing the the first turn. Some video angles unavailable due to technical difficulty. It appeared #2 "Mostly Dali" (D. Edwards – 4<sup>th</sup>) was inside 2 pylons, but was not lapped on at the finish. No change.

**Race6: INQUIRY:** Reviewed racing in the stretch. #5 “Royalty Girl” (B. Galliers – 2<sup>nd</sup> PL 5<sup>th</sup>) comes slightly outwards from the inside, into the path of #7 “Pennys Noir” (A.Sorrie – 5<sup>th</sup> PL 4<sup>th</sup>). #7’s front foot makes contact with the wheel of #5, then #7 stumbles slightly and loses ground. #5 “Royalty Girl” is disqualified from 2<sup>nd</sup> and placed 5<sup>th</sup> – behind #7 “Pennys Noir”, for interference in the stretch. New order of finish: 3-2-1-7
