RACES

Race 1 – Reviewed racing action approaching top of the stretch involving my **#2 Little Mary (M.Salis) (6th)** and **#3 Emilleah (B.Galliers) (8th)**. Video review showed #2 went inside two consecutive pylons before horse bears out taking away the path of #3. #2 finished 6th and was placed 8th for interference, #3 finished 8th placed 7th and was chartered with an “I”. No further action taken by the Judges as it was deemed the horse overreacted to driver’s command.

Race 2 – **Judges Inquiry** looking into the break in stride right before the start by **#5 Gimmie A Corona (A.Sorrie) (2nd)**. After further review, the horse did not violate any of the breaking AGCO rules, no placing needed.
