Back Office:

- Dr. J.A. Ballinger D.V.M. is the on-duty Association Veterinarian this evening.
- From race seven yesterday Driver Trevor Henry was found to be in violation of AGCO rule 22.05.01 (b) (*interference violation*) while driving the horse My Leading Man. Mr. Henry was assessed a three-day driving suspension that shall be served March 8 through March 10, 2026, inclusive. AGCO ruling #3588168
- Driver David Kelly was found to be in violation of AGCO rule 6.02 (a) (*failure to drive when programmed*). Mr. Kelly did fail to drive the horse Catfish Jack in race eight at Mohawk this evening and was assessed a \$100 monetary penalty. AGCO ruling #3588238

R1 – WEG Broadcast had posted the wrong horses names on the side section of the infield screen during the post parade. It was corrected.

R2 – Clear.

R4 – #3 My Buddy Sam (Daryl Thiessen), (finished third) finished with broken equipment (lost a right hind shoe)

R5 – Reviewed racing at the three-quarter pole between #3 Myfriendjose (L.P. Roy), (finished eighth) and #5 Ritchie Rich (James Macdonald), (finished ninth). The horses hooked wheels and remained hooked until the wire. Both horses were marked with interference and no placings were required.

R6 – Reviewed racing before the half. #4 Beach Tour (Doug McNair), (finished seventh) comes out of the hole and forces the #3 Nighttime Dancer (James Macdonald), (finished sixth) three wide. #4 was having trouble while in the hole. No placings required. #3 was marked with interference.

R7 – Clear.

R9 – Reviewed pylons on several horses as the field comes off the last turn. There were no violations.
