Race 1 – Reviewed racing at the half – #9 Johnny Wiggles (Doug McNair) retakes the lead from #10 Calypso Creek (JR Plante), no interference to any trailing horses.

Race 6 – Inquiry – Reviewed racing in the stretch between #4 Needabankloan (Jody Jamieson) and #1 Parlay King (Travis Cullen). The video shows #4 moves out and puts a wheel under #1, which forces #1 to move out. #2 Stone Carver (James Macdonald) is advancing on the outside of #1 and hooks his wheel from behind. Judges reviewed #6 Beach Tour (Doug McNair) and ruled he was clear of #4 and not at fault for interference. #4 finished 3rd placed 8th for causing interference; #1 and #2 were charted with interference. Judges will follow up with Jamieson.
