- Ruling #3627648 – the horse Instantaneous is ineligible to race or enter in the Province of Ontario for 30 days, March 27 – April 26/26, Inclusive. AGCO Rules 9.07.01(iv) & 20.01(j).
- Trainer Paul Court was in for a Review of a Certificate of Positive Analysis for the Class 4 Drug Glycopyrrolate on the horse Stonebridge Helios on March 7/26. Decision reserved.

- Ruling #3627685 – placing of the horse Needabankloan from Race 6 on March 21/26. AGCO Rule 22.09.

- Judges spoke to Daryl Thiessen regarding racing in the first turn in Race 10 on Monday night, no further action needed at this time.
