Race7: INQUIRY: Reviewed the finish. #4 “St Lads Mischief” (G. Rooney #3rd PL 4th) breaks stride immediately before the wire, remains off stride through the wire, and is lapped on by #1 “G A Speed Sammy” (B.Galliers - 4th PL 3rd). #4 is placed from 3rd to 4th for a lapped on break at the wire. New order of finish 2-5-1-4

Sorrie – 2nd PL 1st). #8 appears to be moving past #5, but hooks wheels from behind due to #5 coming outwards. The wheels remain hooked through the wire. #5 is disqualified from 1st and placed 2nd for causing interference to #8 in the stretch. New order of finish 8-5-6-7
