- Race Official Justin Stein is training tonight.
- Early scratches – R1-Ruredyforagoodtime (sick), R2-Totally Iconic (ineligible – needs a trainer transfer), Brydgie (transportation), R3-No Partners (sick), Fiscal Policy (sick), R5-All My Lovin (sick), Kountry Grace (Judges), R8-Chasing Bismarck (stable error).
- R6 – Final Dream was entered incorrectly for a claiming price of \$10,000. The horse is eligible to race for the conditions only. It was announced to the public with the early changes that the horse would not be racing for the published claiming price.
- R8 - Babbling Billy was charted as a “horse” but reported to be a gelding. This was announced with the early changes.
- Phil Hudon was excused from his drive in R8.
