R3 – Reviewed the breaks of #4 D A Merlot (D. Henrikson, 5th), #5 Simply Chaotic (B. MacDonald, 7th), #6 Green Goose (D. Thiessen, 6th). #4 made a break when the horse lost a shoe and was charted with an equipment break. Reviewed racing in the first turn when #1 Buckys Fireball (W. MacLean, 2nd) was inside two pylons. The horse was not lapped on at the finish. No violation.

R4 – Clear.

R5 – INQUIRY – Reviewed pylons in the last turn on #2 Legacys Jailbreak (J. Turcotte, 2nd) who was tight to the pylons. The low pan video shows the wheel of the bike gets inside

one pylon and hits the second. No violation. We also reviewed pylons in the second turn on the winner #1 Pajamas Optional (D. Thiessen). No violation. #6 Tregaron must qualify for making consecutive breaks on fast tracks. Trainer Robert Young was notified.

R6 – INQUIRY – Reviewed the break of #3 Bettor B Home Soon (B. MacDonald, 4th) in the stretch. The horse makes a short break, loses ground, and is pacing through the finish. No violation. Also reviewed the first turn where #3 gets rough but does not break stride.
