Races:

Race 1: #8 Windsun Chelsea made a break before the start but was well inside the fair start pole.

Race 2: Clear.

Race 3: Clear.

Race 4: #8 Lockdown Romeo is on the Judges' list for time here at Woodbine Mohawk Park, 2:03:1, but is still eligible to race on a half mile track.

Race 5: #2 Windsun Gunner, finished 6th, was charted with interference from the break of #4 Kaptainkrave in the stretch, no placings needed.

#9 Domineight made a break before and after the three-quarter pole, pulled up and did not finish. The horse was placed on the Long-Term Vet's list (lame) by the Official Veterinarian and must qualify for performance.

Race 7: **Inquiry:** #5 Just Business (S.Young), finished 4th, made a break before the quarter pole, no violations of the AGCO breaking rules.

The horse was placed for causing interference while off stride to #6 Bayonetta, finished 4th placed 3rd, and for failing to lose ground while off stride. #8 Horse With A Plan (T.Cullen) finished 3rd and was placed 2nd.
