Race 3 – Inquiry – Reviewed racing in the stretch and the break by #2 HP Josephine (JR Plante). The video shows #3 Sunnys Girl (Travis Henry) is moving out from behind horses and is clear of #2. #1 Pipers Luna (Jody Jamieson) is closing on the far outside and remains in her own path. #2 is to the inside of #1 and is visibly running out, and touches the wheel of #1, which causes her to make a break. Neither #1 or #3 were at fault and #2 was ruled to have caused her own interference; charted with an 'ix' and no placings were needed.
