OFFICE

- Race Official Bryan Richardson training this evening.
- Trainer transfer approved on the horse Abovemypaygrade from Mark Goddard to Kyle Bossence.
- Doug McNair – \$100 monetary penalty – failed to drive Check Master in R4 on Friday, AGCO Rule 6.02, Ruling #3638370.
- Paul Court has accepted an AGCO settlement agreement for a Certificate of Positive Analysis for the class 4 drug Glycopyrrolate on the horse Stonebridge Helios from Race 4 on March 7/26. Mr. Court has been assessed a \$500 monetary penalty and three-day full suspension (to be served April 13-15). Mr. Court must also complete the AGCO Equine Medication Use and Awareness program. Ruling #3637707.

- Anthony Hamlin – Ruling #3638438 – AGCO Rule 22.25.02.02(i) – Mr. Hamlin’s license has been downgraded to a ‘C’ Driver and he must accumulate 75 points in overnight races before being upgraded back to a ‘B’ Driver.

- Ruling #3635197 – Driver James MacDonald did hook the wheel of another bike, causing interference, while driving "Zebs Krafty" in race 10 at Mohawk Park on March 28, 2026. Mr. MacDonald has been issued a 3-day-driving suspension, April 6,7,8, 2026. AGCO Rule 22.05.01(h).
