House, 5P4) at the finished and placed for a pylon violation. #7 was not lapped at the finish, therefore no placing was required.

Also reviewed pylons prior to the finish on #5 Wicked Ending (G. Rooney, 3rd). #5 did go inside one pylon prior to the finish line and did not gain an unfair advantage. #5 was also inside a second pylon at the finish line well after his nose had crossed the wire and therefore had already finished the race. No placing required.
