Race 1 – Clear

Race 2 – Clear – reviewed racing after the start - #3 "Mikes Tony" (Galliers 1st) does go inside 1 pylon, no violation.

Race 3 – Clear

Race 4 – Clear

Race 5 – “Inquiry” – going to the ¼, #2 “Music To My Gears” (Filion 5th) makes a break in stride, no violations of the breaking rule. No change. <https://youtu.be/zdvIY2uqwOM>

Race 6 – “Inquiry” – top of the stretch #5 “Delta Rose” (Ketros 3rd) does go inside 1 pylon and hits another, no violation. <https://youtu.be/lroK50UPilq>

Also reviewed racing after the ½, both #1 “Look A Diamond” and #5 “Delta Rose” each go inside 1 pylon, no violations.

#2 “Rosy” made a break in stride after the start, must qualify for “breaks”, interference charted on #4 “Dream Valley”, no placings required.
