Ruling #3730435: As a result of a positive test for a Class IV substance (Naquasone) from a sample taken following Race 8 at Flamboro Downs on April 30, 2026, trainer Michael Pattison has accepted a settlement agreement offer. Pattison is hereby issued a \$500 monetary penalty and a 3-day full suspension from June 4th, 2026 to June 6, 2026 inclusive and must complete the Equine Medication Use and Awareness Program. The horse Watch Me Dance finished first and is hereby disqualified from Race 8 on April 30, 2026 at Flamboro Downs. The new order of finish will be as follows:
