Race 2 – Reviewed break on #7 Buckys Fireball (W. MacLean, 7<sup>th</sup>) at the start. #6 and #7 drift together briefly just after the start. No interference occurred to either horse. #7 makes a break after the fact on her own.

Race 3 – Clear.

Race 5 – Clear. #3 Arrakis finished with broken equipment (knee boot).

Race 6 – Clear. #2 Machalko finished with broken equipment (shoe). #3 Luckiestmanalive finished distanced and must qualify for performance (trainer Bo Ford). #3 was also put on the short-term vet list (sick).

Race 7 – Clear.

Race 8 – Clear. #4 Raising Rusty made a break before the half and finished with broken equipment (shoe). Review of the replay showed the horse was running before the shoe came off, so the horse must qualify for breaks. #7 Run Like Hill also finished with broken equipment (shoe). #9 Nothingbutadreamer made a break before the ¼ pole and pulled up. Must qualify for performance. #9 was also put on the short-term vet list (sick)
