Report on day's events:

Office: Prospect Series 3yo Filly Trot (Races 2,4)

A review was held with General Manager Chad Gates regarding the cancellations of racing after Race 2 on May 23rd and the entire card of racing on May 24th. No further action required at this time.

Horseperson Francis Guillemette was assessed a \$200.00 monetary penalty for violation of AGCO Rules 6.17(d) and 6.20(b), did engage in improper conduct towards the Official Veterinarian after the qualifiers. \$200 monetary penalty. Ruling #3729305.

In Race 11, #1 Kellys Chase was programmed in error, not on Lasix. The horse received and raced on Lasix this evening.

Races:

Race 1: #1 Nasty Reputation, #2 Clodam Bayama, #3 Itll Be Alright, #4 Allstar Smiles, #5 Rambaran Rose, and #9 Tobins Wish were charted with interference from the break of #7 Darlin Dallecktrah after the start, no placings needed.

Race 2: **Inquiry #1:** #1 Abby Rose Men (G.Gagnon), finished 3rd, made a break before and after the start while #5 Mattys Halo (R.Guy), finished 4th, made a break before and after the start. Both horses did not violate the AGCO breaking rules. No placings needed.
