Race 4 – Recall – #7 Southwind Russian (Stephane Pouliot) interfered with #9 Kadiddle (Scott Young). Race All Clear.

Race 5 – Removed racing in the second quarter – #4 Mike Me Up (LP Roy) races three-wide, #1 Thor B Good (Jonathan Drury) and #9 Strobe Lite (James Macdonald) had room to move off the rail.

Race 6 – All Clear

Race 7 – Objection – #4 Perfetto (Dagfin Henriksen) on #6 Myfriendjose (Doug McNair) going into the first turn. Mr. Henriksen stated #6 crossed over and hit his horse. Mr. McNair felt he was clear going to the lead. The video does not support interference by #6. #3 Bella Cavalla (LP Roy) and #4 hook wheels; both horses were charted with an 'ix'. Objection disallowed and no placings.
