Race 11 – Inquiry – Reviewed racing in the third quarter where #1 All My Lovin (Tyler Borth) and #9 Major Threat (Daryl Thiessen) hook wheels. The video shows #9 is not clear of #1's wheel when advancing on the outside and hooks the wheel of #1 from behind. There is no video evidence of #1 moving out into the path of #9. As a result, trailing horses #2 Starlit Millertime (James Macdonald), #4 Blazing Cruiser (Billy Davis), #6 Sos Sports Bet (Mark Macdonald), #7 Thai Tour (Brett Macdonald) suffered interference, while #5 Backup Plan (LP Roy) was charted with an interference break. #9 finished 3rd placed 10th for interference. Judges will follow up with Thiessen.
