R1 – Clear. #1 Outlaw Jesse James (B. Le Cain, 7th) made a break in the first turn must qualify for breaks. The paddock judge was notified.

R2 – Reviewed pylons after the 1/2 mile. No violations.

R3 – Clear.

R4 – Clear.

R5 – Reviewed the start for possible broken equipment on #5 Skoden (A. Sorrie, 4th) and #6 Road Promises (M. Horner, 2nd). None before the start. Both horses finished the race with broken equipment (#5, head pole and #6, knee boot). #2 Toscano Girl (J. Ryan, 7th) made a break at the head of the stretch and must qualify. The paddock judge was notified.

R6 – Clear.

R7 - #8 Lilly Clare lost a shoe in the race and was charted with broken equipment (be).

R8 – Reviewed the first turn for a possible pylon violation by #1 Tainted Love (M. MacDonald, 4th). Inside one pylon only. No violation.

R9 – INQUIRY – Reviewed pylons in the final turn on #6 MS E Elliot (J. Jamieson, 3rd) who is inside two consecutive pylons but not lapped on at the finish. No violation. #4 Thwarted (B. Galliers) is on top at the head of the stretch, makes a break, and follows the breaking rules to finish 5th. #2 Just Call Me Bella (K. Jones, 6th) makes a break before the start and must qualify for breaks. The paddock judge was notified.

R10 – INQUIRY – Reviewed the break before the 1/4 by #5 Look A Diamond (J. Ryan, 4th). No violation.
