- Early scratch – Isn't Easy in R3 (Vet Sick)
- A number of drivers were excused today due to 2yo qualifying races at Mohawk being canceled on Thursday and moved to today.

R1 – Clear.

R2 – Clear. Pouncing Panther finished the race in 2:04.3 and must qualify. Trainer Joseph Shaw was notified.

R3 - #3 Captain Eight (L. Gregg, 4th) finished with broken equipment (boot).

R4 – Reviewed pylons in the last on #2 Greystone Cheeto (Tre Henry, 5th). No violations.

R5 – Clear.

R6 – INQUIRY. Reviewed racing before the quarter mile where #8 Dakota Sena (Scott Young, 7P8) gets jammed up and causes interference to #7 Jitterbug Flip (R. Holiday,

8P7). Also reviewed racing before the start where #3 Keystone Dakota (M. Etsell, 5P6) shies and bears in causing interference to #2 Jayport Beach (A. Dick, 6P5). #2 was a complete pari-mutuel refund of \$528.

R7 – INQUIRY. Reviewed racing in the stretch where #2 Bee Swell Smiley (P. MacKenzie, 7P8) is on top and makes a break, causing interference to several trailing horses. #2 must qualify for breaks. Trainer Brian Schewfelt was notified. Also reviewed the break of #5 Buy Mediamonds (J. Ryan, 6th) after the start. No violations.

R8 – INQUIRY. Reviewed racing in the stretch where #2 Boomandbust (P. MacKenzie, 3P4) breaks stride just before the finish and is lapped on by #6 Charmbo Chip (J. Ryan, 4P3), resulting in the placing.
