### Report on day's events:

### Office:

- Early Judges scratches (other) of GARFIELD GASS (Reg Gassien trainer) from the first race and GERONIMO CREEK (Barry Bird trainer) from the second race.
- Early veterinary scratch (sick) of MOSSIES ART (Jason Mitchell trainer) from the tenth race; this horse is entered on the short term (seven days) Veterinarians list.
- Dwayne Hay requires nine satisfactory drives in order to be eligible to race in overnight events.

### Races:

- Murray Brethour excused from one drive.
1. The #5 ORVILLE (Gord Brown) must qualify for breaks in consecutive races on a fast track (trainer notified). Clear.
  2. The starter, Steve Skeen, discussed the performance of #7 FREIGHT DAYS AWEEK with the driver (Doug Hie). Clear.
  3. Clear.
  4. Reviewed the break by #1 B MAX (Allan Molloy) in the stretch; #1 did break stretch and finish and was double lapped on by #4 FINAL RINSE (Nicholas Boyd) and #6 VELUCANDOITCUPCAKE (Mike Healey); #1 finished fifth placed seventh (AGCO rule 22.27). Clear.

- Delay due to weather (lighting in the area) of approximately 25 minutes.
- 5. Clear.
- 6. Reviewed racing between #2 ALWAYS ADELE (Ryan Guy) and #4 MY ONLY SUNSHINE (Gord Brown) after the ½ mile pole; #4 was on the rail and moved out with clearance of #2; no violations. The driver of #1 HOTTUBPOPPINBUBLY, Drew Smyth, had an official warning entered on his licence regarding his urging in the stretch. Clear.
- 7. Clear.
- 8. Reviewed the performance of #1 DENIMDAN DELIGHT (Anthony Haughan) and #2 DEALERS CALL (Daniel St. Pierre) after the start; both horses made breaks on their own; no violations. The #2 must qualify for breaks in consecutive races on a fast track (trainer notified). Clear.

The driver of #3 BET ON BRETT, Carter Gimlett, was cautioned regarding allowing the trailing horse #8 THE COLT (Nick Boyd) to pass on the inside; no penalty to Mr. Gimlett regarding 22.05.01(e) as his horse was clearly tiring and drifting out. The #4 THE DEVIL YOU KNOW (Reg Gassien) suffered broken equipment (head pole) after the ½ mile pole and finished with broken equipment. Clear.
