Ruling #3733095 generated – Driver Daryl Thiessen did hook the wheel of another race bike causing interference to other horses, while driving Major Threat in race 11 at Mohawk Park on May 30, 2026. Mr. Thiessen has been issued a 3-day driving suspension June 8,9,10, 2026. AGCO rule 22.05.01(h)

Races:

Race 1 – Clear – reviewed the last turn, #6 "HP Sophia" (Plante) made a break in stride, interference charted on #9 "Stormont Shanlyboy" (T Jones 2nd) causing #9 to become rough gaited.

#5 "Getmesomeofthat" finished distanced, must qualify for performance.
