KReport on day's events:

Approved trainer transfer for the horse "Its Major Major A" from Rene Bourassa to Mark McKinnon.

Races:

Race 1: #2 "Dewenitforthemoni" (Tr. Henry 5th PL 6th) went off stride in late stretch and through the finish. Was not lapped on at the wire, but did fail to lose ground while off stride, and thus was disqualified from 5th and placed 6th behind #9 "Pink Gin Fizz" (J. Jamieson 6th PL 5th), who finished close behind #2.

Race 2: Stewards spoke to Louis-Philippe Roy (#7 "Pa Lily") about the slow second quarter. Accepted explanation of a quick first quarter and the fact it was a race consisting of 2 year old first time starters. No penalty.

Race 3: Reviewed racing in the stretch. JR Plante (“Blast of Sunshine” – 5th) did make the necessary effort to attempt to keep the inside closed to the eventual winner, #6 “Smokestack” (Tra. Cullen – 1st).

Race 4: Clear.

Race 5: INQUIRY: Reviewed racing in the stretch near the fair start pole between #4 “Over Bet” (D. Thiessen – 2nd PL 3rd) and #6 “D A Bodacious” (J. Jamieson 3rd PL 2nd). Spoke with both drivers and reviewed all available video angles. Video shows that #4 moves outward slightly into the path of #6, whose foot strikes the wheel of #4, costing him considerable momentum. As a result, #4 is disqualified from 2nd and placed 3rd behind #6 for interference. New order of finish 2-6-4-8
No penalty assessed to Mr. Thiessen as his horse was bearing out and he made efforts to keep the horse on a straight path.

Race 8: Reviewed racing at the ½ mile pole. #4 “Makina Run For It” (D. Thiessen – 9th) runs up into the back of #1 “Kenogomi Fancy” (M. MacDonald – 4th) as the field slows slightly, and makes a break. No further action required.

Race 9: INQUIRY: Reviewed break of #1 “Landing On Time” (LP Roy – 4th) in late stretch. Horse makes a break, loses ground while off stride. Once back trotting through the finish, horse does hold on for 4th place.
No violation of the breaking rule. No change.
