## OFFICE

- A Drivers Meeting was held to discuss the new penalty structure for AGCO Rule 22.05.01 for on-track driving violations for the following rules while driving at Woodbine Mohawk Park:

**22.05.01** A driver shall not commit any of the following acts which are considered violations of driving rules:

- (e) Allow another horse to pass needlessly on the inside, or commit any other act that helps another horse to improve its position;
- (i) Lay off a normal pace and leave a hole when it is well within the horse's capacity to keep the hole closed without promptly pulling to re-pass the horse, unless the failure to re-pass is necessitated for safety reasons;
- (k) Fail to set or maintain a pace comparable to a pace that the calibre of horses in the race are capable of, resulting in an excessively slow quarter or any other distance, considering track conditions, weather and circumstances confronted in the race;

Beginning June 2026, the new penalty structure for races at Woodbine Mohawk Park will be as follows:

- The monetary penalty amounts listed above are the minimum penalty that will be imposed by the AGCO Race Officials. The Race Officials will use their discretion when determining the appropriate penalty.
- A higher penalty, according to the penalty structure, will be imposed for repeat violations of the same rule occurring within six months of a previous violation.
- Any driving suspensions must be served on Woodbine Mohawk Park race dates.
