Race 1 – All Clear

Race 2 – Inquiry – Reviewed racing in the stretch between #3 In Session (Tyler Jones) and #5 Arkona Seelster (Tyler Borth). The video shows #5 darts in on Borth and touches the front leg of #3. #5 finished 2nd placed 4th for interference; no penalty to Borth.

- Reviewed the second quarter (:27.2, :58.2) – #8 Satu Wania (Trevor Henry) clears to the lead well past the quarter; given the class (maiden trotters), no violation of AGCO Rule 22.05.01(k).

Race 3 – All Clear

- #6 Very Sassy finished the race with broken equipment (shoe).

Race 4 – Reviewed pylons on #2 Volcanic (Doug McNair) at the top of the stretch, finished 2nd – races inside one pylon, no violation of the AGCO pylon rule.

Race 5 – All Clear

- #1 Myretirementdream (Jody Jamieson) finished distanced and must qualify for Performance, Tr. Eli Wagler. The horse was placed on the short-term Vet's list (sick).

Race 6 – Inquiry – Reviewed the break by #3 Just All Out (Scott Young) before the start – not inside Fair Start Pole, Refund \$17,590.

Race 8 – Reviewed racing in the stretch when #1 Up To No Gouda (Travis Henry) is off the rail and #6 Notatthetablecarlos (Stuart Sowerby) advances on the inside. Mr. Henry stated he was trying to stay wide around the final turn as his horse was running in and he wanted to avoid going inside pylons. The horse then ran out on him coming off the turn and Sowerby had an open lane. The apex video confirmed Henry's explanation and no further action is needed.
