Race 4 – Clear. #2 Whitty Wheels and #7 HP Shefford made breaks and must qualify for breaks.

Race 5 – Reviewed racing going to the half. #1 Czarette (B. Galliers, 7P9) runs up on #2 Awesome Hill and causes interference to #9 Silver Majesty (G. Gagnon, 4th), #7 Tornado Seelster (E. Hensley, 9P8) and #6 Panthermonium (D. MacLellan, 6th).
