Office:

- Following on issuance of AGCO [Administrative Directive No. 1 2026 \(Air Quality\)](#) concerning air quality standards for racing, the air quality based on Ontario Air Quality Health Index (AQHI) readings was determined as being satisfactory to allow racing.
- Early Judges scratch (injured) of NAZARE (Mathieu Joannette trainer) from the ninth race.
- Driver Normand Joannette requires four (4) satisfactory qualifying drives to be eligible to drive in overnight events.
- Early Judges scratches (other) of KING TRIXTON (Gary Oliver trainer) from the fourth race and GURL SWAG (Stephen Gassien trainer) from the fifth race.
- Early veterinary scratch (sick) of APACHE CREEK (Barry Bird trainer) from the ninth race; this horse is entered on the short term (seven days) Veterinarians list.

Races:

1. Reviewed the break by #6 DALI UNITED (Gord Brown) before the ¾ mile pole; while off stride #6 did cause interference to #3 ALLSTAR SHOTS (Bradley Rae), #7 BAD BETTING (Dale Spence) and #8 B MAX (Nicholas Ahern); no placing necessary as #6 finished posterior to all horses interfered with. Clear.
