**Race 2:** #2 B Max, finished 8<sup>th</sup> placed 7<sup>th</sup>, was charted with an interference break, #4 O So Amy, finished 4<sup>th</sup>, charted with interference after the start when #5 Back In A Flash (M.Healey), finished 7<sup>th</sup> placed 8<sup>th</sup>, was crossing over after the start.

Reviewed the break of #8 Lenys Girl before the half.

**Race 3:** #5 Dealers Call was charted with an interference break from the break of #8 Watch And Believe after the three-quarter pole. No placings needed.
