Race Report

Race 1: Clear.

Race 4: Inquiry. Reviewed racing action past the three-quarter pole involving #2 and #5. Racing was tight as #5 was clearing on the outside. After reviewing the reply, there were no violations.

#2 was inside two consecutive pylons and was not lapped on. No placing required.

Race 5: Clear. Prior to the post parade, the paddock judge contacted the Judges' Stand regarding a possible driver change on #3 Miss Gracie Ridge. The official program printed on track listed Ambyr Campbell as the driver, while the paddock judge advised that Brodie MacPhee was scheduled to drive. While the official program available to the public listed Ambyr Campbell, the digital program on the Red Shores website, the entries on Standardbred Canada, the official chart and on HPI all listed Brodie MacPhee as the driver. Ambyr Campbell was contacted and confirmed that she had listed Brodie MacPhee to drive at the time of entry. As a result of the clerical error on the official programs printed on track and the timing of noticing the difference, the horse was barred from wagering and raced for purse only.

Inquiry. Reviewed racing action prior to the start involving #2. The horse was tardy behind the gate and made a break while attempting to catch the gate. After consultation with the starter, it was determined that all horses received a fair start.

Race 7: Inquiry. Four of the five horses in the race made breaks, with two making multiple breaks. All breaks were reviewed. All horses complied with the breaking rules. No violations.
