Report on day's events:

- Sam Fillion excused from his drives today.

R1 – Clear

R2 - #4 and #5 were charted with interference after the start where #8 Heavenly Wicked (Tra Henry, 8th) went off stride.

R3 – Prospect Series – 2yo Fillies – Leg 3B. Clear.

R4 – INQUIRY – Reviewed racing going to 3/4 where #3 Playatyourownrisk (Tra Henry, 3rd) gets rough but does not break stride. Reviewed the break by #6 Beachwash (A. Sorrie, 8th) before the 1/4 that caused most of the field to scatter. Also reviewed pylons in the first turn. #8 Wicked Plan (L. House, 4th) was inside two pylons but not lapped on at the finish. No violation.

R5 - #2 Beethreepo (B. Galliers, 7th) made a break in the first turn, causing interference to #3, #4 and #7. #2 also finished with broken equipment (hobble hangers) which the Judges confirmed broke after the incident.

R6 – Prospect Series – 2yo Fillies – Leg 3B. Clear.

R7 – Clear. Before the 7th race, from **R10 #1 All Bets On Me** was scratched for being late for retention, in accordance with SB Rule 26.12. Trainer Bradley Vanstone.

R8 - Prospect Series – 2yo Fillies – Leg 3B. INQUIRY – Racing is tight at the head of the stretch. #3 Reenee (Tra Henry, 5th placed 6th) does bear out causing interference to #5 Lyons Bentley (D. MacLellan, 6th placed 5th). After speaking with both drivers, the Judges confirmed the incident was attributed to a young, tiring horse. #2 Bully Tina (M. MacDonald, 7th) finished the race with a flat tire (be).

R9 – Clear. #6 U No Peach (O. Gois, 7th) lost a shoe in the race and was charted with broken equipment (be).

R10 – Clear.
