Report on day's events:

Office:

Early scratches – Playful Dancer R1 (sick), Riskofthunderstorm R3 (sick), Always Been Crazy R3 (sick), Seaside Flirt R4 (sick), The Dancing King R5 (sick), Timewaitsonnoone R11 (Judges), Toscano Girl (sick).

R1 – INQUIRY – Reviewed the break in stride on the final turn of #7 Happy Jeff (J. Jamieson, 3rd placed 5th). #7 was placed back to for causing an interference to #5 Allstardancingking (R. Doyle, 5th placed 4th) who had to leave the course to avoid #2 Colombo Ray (S. Fillion, 2nd) who made a break as a result of the interference.

R2 – INQUIRY – Reviewed the break in stride on the final turn of #7 Bee Swell Smiley (L. Gregg, 5th) who scattered #1,2,3,and 6. All were charted with interference. No placing required. Also reviewed the start where #4 Diamond Diva (G. Ketros, 6th placed 7th) made a break before the start causing interference to #5 Vanilla Bean Queen (R. Guy, 7th placed 6th). #5 did not receive a fair start and was a pari-mutuel refund of \$472.

R6 – INQUIRY - Reviewed the start when #1 Rocky MTN Wine (E. Stephenson, 8th) goes off stride. After reviewing the video and speaking with driver Louis Gregg, the Judges determined that #8 Irish Dali received a fair start.

R7 – Clear. No Hard Feelings (Tra Henry) was distanced in the race and must qualify for performance. Trainer Mark Etsell.

R8 – Clear. First-time starter B Twenty Five (S. Fillion) was distanced in the race and must qualify for performance. Trainer Camilla Christoforou.

R9 – Clear.

R10 – INQUIRY - #5 Nevada Dragon (R. Guy) wins the race. In the first turn #5 is not clear to cross over, has no pressure on the outside, and does take away the lane from #2 Larjon Lilly (L. House) causing this horse to break stride. After reviewing the video and speaking with the drivers, #5 was placed 8th behind #2 for causing interference. Judges will follow up with driver Ryan Guy regarding penalty.

R11 – Clear. The Judges reviewed the circumstances around the apparent double entry of Timewaitsonnoone, who was scratched at Clinton today and raced at Leamington. Trainer Cameron McQueen. Decision reserved.
