R8 – Review the break of #5 All Day Hanover (J. Comegna, 8th) before the 1/2, sitting second. #5 gets into the safety lane and all horses get by without interference.

R9 – OSS Gold Leg 4 – 3yo Trotting Colts. Reviewed racing at the 1/2 where #4 Strobe Lite (J. MacDonald, 6th) hesitates after he cleared, causing interference to #5 Touchedbyanangel (D. McNair, 5th). No placing required. Electronic timer malfunctioned. Fractions were 27.1, 55.4, 126, 154.4.

R10 - #9 Bet The Macks (J. MacDonald) made a break and pulled up after the start with a broken hopple. The rest was clear.
