Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Early veterinary scratch (sick) of WICKED JOULES (George Graham trainer) from the seventh race; this horse is entered on the short term (seven days) Veterinarians list.
- Mike Healey will attend a review regarding a possible violation of AGCO rules 6.02(e) (disturbing the peace) and 6.17(d) (improper conduct).

Races:

- Kirk Thomas and Doug Brown each excused from one drive.
1. Reviewed the break by #2 DARRELL (Doug Hie) before the ¾ mile pole; while off stride #3 did cause interference to #3 KATYS DELIGHT (Gord Brown); no placing necessary as #2 finished ninth (last). Clear.
 2. Clear.
 3. Inquiry concerning possible interference at the start of the race; #3 BENJAMIN BLUE CHIP (Nick Boyd) broke after the start but did not cause interference to the trailer #9 MATTYS HALO (Doug Brown); no change to the order of finish. The #4 ORVILLE

(Gord Brown) must qualify for breaks in consecutive races on a fast track (trainer notified). Clear.

4. Reviewed the break by #3 DG HOLI SHAMOLIE (Jeffrey Hunt) after the ½ mile pole; while off stride #3 did cause interference to #1 GIMMIE A CORONA (Gord Brown) who finished with broken equipment (shoe), #4 PL SUZIE (Nicholas Ahern), #6 HOWYOUPLAY THEGAME (Reg Gassien) and #7 WICKED PRINCE (Clarke Steacy); no placing necessary as #3 finished ninth (last). Clear.

8. The driver of #3 HARDOO PARKING, Darcy Clancy, was cautioned regarding his urging in the stretch. Clear.

Inquiry and driver's objection concerning possible interference by #4 GIVE ME KARETS (Mike Healey), who finished third, on #1 LMC LITTLE CHIPS (Dale Spence), who finished fifth, before the ¼ mile pole; after reviewing the race video and speaking with the drivers: Mr. Spence stated that #4 had beared down from three wide into #3 GIM HANDSOME (Gord Brown) who was two wide and finished sixth, forcing him into #1 who was forced to contact the pylons; Mr. Brown stated that #4 was tight on the outside but did not interfere with #3 while Mr. Healey stated there was sufficient clearance, the objection was disallowed; no change to the order of finish. Clear.
11. The driver of #6 ALL ABOUT ART, Doug Hie, was cautioned regarding his urging in the stretch. Clear.
