Race 1: Reviewed the break of #8 Hayicanfly after the start.

Race 2: Clear.

Race 3: Clear.

Race 4: #6 Freight Days Aweek finished 7th and was placed 8th for a pylon violation after the quarter pole, the horse also finished with broken equipment. (hobble hanger)

#7 Kaptainkrave finished with broken equipment. (shoe)

Driver Michael Healey was found in violation of AGCO Rule 22.05.02(k), did fail to set a pace comparable to class while driving #1 Jj Xavier. The second quarter was time in 32:1. \$100 monetary penalty. Ruling #3875710.
