Race 1: Inquiry: #6 Coral Cliff (T.Jones), finished 4th, made a break after the start but did not violate any of the AGCO breaking rules.

#2 Jyn Erso was charted with an equipment break (tire) after the quarter pole, pulled up and did not finish.

#5 Midwind Meme, finished 7th, and #9 Cooler Fashion, finished 6th, were charted with interference breaks after the quarter pole. No placings needed.

Race 2: Clear.

Race 3: Reviewed the breaks of #3 Th Patrick, #6 Cornaro Kid and #8 Lets Play Ecurie before the start. All horses were well inside the fair start pole.

#6 Cornaro Kid and #8 Lets Play Ecurie must qualify for breaks.

Race 4: Inquiry: #1 Chex Mix (L.P.Roy) made a break before the start but was outside the fair start pole and was a pari-mutuel refund of \$26369.
