Race 4 – Inquiry – Reviewed the break by #1 Social Wizard (Tyler Borth) after the start, finished 4th – no violations of the AGCO breaking rule.

Race 6 – All Clear

Race 7 – Reviewed racing in the stretch – #4 Hazee Coast (Tyler Borth) is on the lead and #7 Moonlover Bovino (Travis Henry) passes on the inside to win the race. Mr. Borth attempted to keep the inside lane closed off, but the horse was running out on him. #7 had room to pull out of the two-hole and elected to stay on the inside. No violation of AGCO Rule 22.05.01(e). Judges also reminded Mr. Borth about allowing his foot to contact the horse.

Race 8 – All Clear

Race 9 – #3 Hesincontrol (Jonthan Drury) finished 8th placed 9th for racing inside 11 consecutive pylons in the stretch.

Race 10 – Inquiry – Reviewed the break by #3 Freight Days Aweek (Phil Hudon) before the start – not inside the Fair Start Pole, Refund \$24,117. No Inquiry video available as the horse was too far back.
