R1 – Prospect, 2yo filly pace, Leg 5A. Clear.

R2 – Reviewed the start where #1 Feet of the Moon (J. Harris, 6th) makes a break before the start and is well inside the fair start pole when the field reaches the start line. Also reviewed pylons at the stretch. No violations.

R3 – Prospect, 2yo colt and gelding pace, Leg 5A. Clear.

R4 - Prospect, 2yo filly pace, Leg 5A. Clear. Reviewed the break of #3 at the start. No violations.

R5 – INQUIRY – Super HI-5. Reviewed racing in the stretch for possible interference by #6 Duck Dynasty (S. Pouliot, 5th) on #3 Show Stop (B. Galliers, 8th). After reviewing the video and speaking to driver Brady Galliers, it was determined that there was no interference. Dead heat for 5th place between #2 and #6.

R6 - Prospect, 2yo filly pace, Leg 5A. Clear.

R7 – Reviewed all breaks in the race. No violations. #5 Sneaking Out (D. Boughton, 7th) must qualify for breaks. Trainer Donald Lindsey.

R8 - Prospect, 2yo colt and gelding pace, Leg 5A. Reviewed the break in stride of #5 Happy Jeff (T. Ratchford, 6th). No violation, but the horse must qualify for breaks. Trainer Carl Jamieson.

R9 – Clear.

R10 – INQUIRY - #5 Crazy World (B. Galliers, 4th placed 6th) made a break in stride late in the stretch and was lapped on by #8 and #4.
