Report on day's events:

Office:

- Two divisions of Ontario Sires Stakes Prospect series for two year old filly trotters and one division for two year old colt and gelding trotters.
- Early veterinary scratch (sick) of WORLD REVIVAL (Joe Pascoe trainer); this horse is entered on the short term (seven days) Veterinarians list.
- Early Judges scratches (transportation) of DAY TRADER from the seventh race and NAZARE from the ninth race (Mathieu Joannette trainer of both horses).
- Trainer Meg Crone was adjudged guilty of violating AGCO rule 17.19 (failure to name the driver) concerning NORTHERN QUEEN in the sixth race and was assessed a monetary penalty of \$100 (Number 3895818).
