Race 2 Inquiry at the start. #8 Takeapeek At Me made a break and was not inside the fair start pole. Refund of \$3,834

Jonathan Drury was found to be in violation of AGCO rule 22.05.01 K (failed to set a pace comparable to the class). Monetary penalty of \$200. Ruling #3886832.

Race 3 Reviewed the stretch where the winner #1 Solar Voltage (Cullen) does pass on the inside of #2 Stay Fresh (McNair). Video shows that #2 does drift out and McNair did make attempts to keep horse down along the pylons, no penalty to McNair.

Race 7 Inquiry at the start. #7 Shadow Of An Angel made a break and was not inside the fair start pole. Refund of \$53,576.
