ESTIMATED PURSE \$31.134 ADDED

Conditions:

- 1. Nomination fee of \$100.00 due May 15, 2008 will be added to the purse of the championship final. Nomination fees must be **clearly post marked** on or before May 15th and sent to Standardbred Canada, the administrators of this stake. Please **make cheques payable to Standardbred Canada**.
- 2. To be eligible for nomination, mares must be 4-years-old or older and must be Canadian sired and/or 100% Canadian owned as of January 31, 2008 and remain in Canadian ownership for the duration of the series.
- 3. All events will be conducted under the rules and regulations of the Maritime Provinces Harness Racing Commission.
- 4. All dashes at a distance of one mile.
- 5. Post positions for events will be drawn by lot.
- 6. Purse distribution: 50%, 25%, 12%, 8%, 5%.
- 7. Declarations close at the time and date declared by the host track.
- 8. Starting fee of \$100.00 payable on the day of the race, one hour before post time.
- 9. The top eight (8) money winners in the preliminary legs will qualify to race in the championship final. In the event there is a tie for 8th place, the 8th horse will be drawn by lot.
- 10. In the event, any of the top eight (8) money winners does not declare to start in the final, the next highest money winner(s) will be deemed eliqible to race in the final.
- 11. Also eligibles for the final will be the (AE1) mare with the 9th highest money winnings in the preliminaries and (AE2) mare with the 10th highest money earnings in the preliminaries.
- 12. The host track reserves the right to reject any money entry, declare off any event if the conditions warrant, and to call off any event that is not filling satisfactorily.
- 13. In the event of unforeseeable circumstances preventing the racing of an event, the host track reserves the right to carry races to future race dates at their discretion, subject to the approval of the stakes sponsors.
- 14. Each host racetrack will add \$2,000.00 for one division of the leg and \$1,000.00 per division thereafter.

STARTING FEE: \$100 for each event, payable on day of the race at the host track
