2008 LADY CROCUS STAKE

FOR: For foals of 2005. To be raced as 3-year-old pacing fillies in 2008 that are registered with Standardbred Canada or the United States Trotting Association prior to the date on which nominations close (May 15, 2008) and are (a) sired by a stallion that stood in Canada for the entire 2004 breeding season, AND/OR (b) non-Canadian sired fillies that are wholly owned by residents or citizens of Canada as of January 31, 2008 provided that: (i) if the owner is a partnership, stable, corporation or a similar entry, all partners, members or shareholders must be residents or citizens of Canada; (ii) if leased, both lessors and lessees must be residents or citizens of Canada; (iii) to remain eligible to either event, fillies must continue to be wholly owned by residents or citizens of Canada from time of nomination and until the time the event is contested; (iv) the sale of a nominated filly to a non-resident or non-citizen of Canada eliminates it from further eligibility as of the date of the sale, and (v) all sales of nominees both before and after nominations must be bona fide sales. For the purpose of these conditions, "residents of Canada" are persons who maintain their permanent residences in Canada at the time nominations close and resided in Canada for at least 183 days in 2007. "Citizens of Canada" are persons who maintain their Canadian citizenships. **If not Canadian sired, fillies must remain in 100% Canadian ownership from January 31, 2008 through to the date(s) of racing.**

PURSE: \$6,000 Added

NOMINATION FEE: \$20.00 nomination fee due **MAY 15th, 2008**
(to be received or postmarked no later than May 15th, 2008)

DECLARATION FEE: \$100.00 due at time of declaration (starters must be declared at or prior to the closing time as per condition sheet)

DATE: Divisions raced on **Saturday, August 2, 2008 @ Killarney, MB**

CONDITIONS:

1. To be raced at a distance of one mile.
2. The purse shall be distributed on a 50%, 25%, 12%, 8%, 5% basis.
3. In the event of more than one division, declarations to be divided by lot with entries seeded.
4. Purse monies and nomination fees to be divided equally among the divisions with declaration fees allocated to the appropriate divisions in relation to the number of horses drawn to each.
5. Starters must be declared at or prior to the closing time as per condition sheet.
