The early vet scratch of BET ON BLAKE from the fourth race was entered on the short-term vet list.

Trainer Joshua McKibbin is in violation AGCO Standardbred Rule 20.03.01(i). Stable error scratch of the horse "LARRYS GIRL" from Race 1. This is the second occurrence within 12 months by Mr. McKibbin and he is hereby ordered a monetary penalty of \$300.00. Ruling #1259455.

**Races:**

R1 – Breath strip utilized. Reviewed the break before the start of #5 MENSA (N. Steward, 8<sup>th</sup>). No violations, all horses received a fair start. #8 ALL R WISHES (S. Johnson, 7<sup>th</sup>) received an interference break after 3/4s and individual variant of 1 second for time lost by the interference. No placing needed.

R2 - Clear.

R3 – Reviewed racing after the start, #9 PRESTIGE WORLDWIDE (T. Borth) finished 7<sup>th</sup> placed 9<sup>th</sup> for causing interference while on a break to #3 CHARMBO PRINCESS (M. Saftic, 9<sup>th</sup> placed 8<sup>th</sup>). #3 charted with an interference break (ix) and given an individual variant of 1 second.

R4 – Reviewed pylons in the last turn on #5 KODIAK SEELSTER (C. Matthews, 5<sup>th</sup>). No violations. Reviewed urging in the stretch of driver Chris Matthews. Judges will forward video and follow up with the driver.

R5 – INQUIRY – Reviewed the break before the start of #1 RADICAL JJ (C. Kelly, 6<sup>th</sup>). No violations, all horses received a fair start. #7 HOPE SO (A. Sorrie, 9<sup>th</sup>) must qualify for consecutive breaks on a fast track. Trainer Robert McIntosh notified.
