Race Official panel of Larry Hughes, Brian Arrand and Emma Pote convened to discuss the scratch of the horse "Azucar Pipedream" from race 7 on June 30,2021 here at Grand River Raceway.

Decision is as follows;

Violation of AGCO rules 5.11 and 6.20 (b), Mr. Hamm failed to follow the direction of the Race Officials and misconduct prejudicial to the best interests of racing. Monetary penalty of \$1,000. Ruling # 1247376

Violation of AGCO rule 17:17, Mr. Hamm scratched "Azucar Pipedream" without the permission of the judges. Monetary penalty of \$500. Ruling # 1247408.
