Early transportation scratch of LARJON LUCKY (tr. Larry Lane) from the fourth race. The early vet scratch (lame) of GOTTA HAVE FAITH from the eighth race was entered on the short-term vet list.

R1 – Clear

R2 – Reviewed the break in the first turn of #1 STANFORD SEELSTER (A. Sorrie, 8<sup>th</sup>). Trainer Kieth Hastie was notified that the horse must qualify for consecutive breaks on a fast track. #6 PANERIA (7<sup>th</sup>) and #8 E L WILDSPORT (3<sup>rd</sup>) were charted with interference (i).

R3 – Clear

R4 – Reviewed racing after the half for possible pylon violation by #5 DARLING PLEASE (B. Richardson, 5<sup>th</sup> and lapped by #6). Over one pylon, no violation.

R5 – Reviewed racing before and after the start. #6 GOOD AND SWEET (B. Richardson, 6<sup>th</sup>) makes a break before the start. No violations. #2 FERN HILL BREEZE (P. Keetch, 7<sup>th</sup>) breaks stride on the first turn, causing interference to #1 SABINE PASS (P. Davies, 5<sup>th</sup>) and #5 EASY FLYER (R. Desroche, 3<sup>rd</sup>). #1 and #5 charted with (i).

R6 – Reviewed racing before and after the start. #3 PDQ HANOVER (T. Henry, 8<sup>th</sup>) broke stride before the start. No violations. #8 CROOKSIE (T. Moore, 5<sup>th</sup>) broke stride before the start. No violations. #7 BIG LADY J (C. Schneider, 7<sup>th</sup>) must qualify for performance. Trainer Cassidy Schneider notified.

R7 – Clear

R8 – Reviewed racing after the start. #4 ANOTHERSTARISBORN (J. Gaskell, 7<sup>th</sup>) moved on to the rail going into the turn while #8 THESPORTSMAN (T. Moore, 6<sup>th</sup>) was moving to close the gap. Contact was caused by both parties and #4 and #8 were both charted with an interference break (ix)
