Report on day's events:

(Accidents, claims, fines and/or suspensions, objections and/or disqualifications, refunds and any other pertinent incidents)

Office:

- Two Ontario Sires Stakes Gold Divisions for both 3YO Colt and Gelding Trotters and 3YO Filly Trotters.

- Two rulings were completed by the Panel of Race Officials Stewart, Minler and Stiff regarding Drew Neill.

- Ruling #1243676 – AGCO Rule 5.11 – Mr. Neill is immediately suspended for failing to follow the order of the Race Officials and contact Compliance Official Brian Sharpe.
- Ruling #1243750 – AGCO Rule 6.15 – Mr. Neill is immediately suspended until the monetary penalties of AGCO Rulings 1110661, 1116787, 1178813, and 1178829 have been paid in full.

Races:

Race 1 – Reviewed pylons on #5 Imextraspecial (Trevor Henry) in the first turn, finished 2nd – #5 was inside one pylon and hit multiple pylons, no violations.

Race 2 – Reviewed multiple breaking horses in the first quarter.

- #2 Mystic Markle (Eddie Green) finished 7th placed 8th (and subsequently 7th) for an extended break. AGCO Rule 22.27.02.

- #7 Magnolia Lane (James MacDonald) finished 5th placed 8th for an extended break. AGCO Rule 22.27.02.

- #5 HP Felicity (LP Roy) was charted with interference due to the break by #6 Silver Diamond (Sylvain Filion) at the 3/4s.

- #9 Global News was a late vet scratch (lame). Refund \$1,510.

Race 3 – Inquiry X 2

- Inquiry #1 – Reviewed the break by #3 Dealin With Dewey (Mario Baillargeon) in the stretch, finished 2nd. #3 is off stride at the wire and lapped by #1 Lexus Kody (Trevor Henry) and #7 Royal Tyrone (James MacDonald); therefore, #3 finished 2nd and placed 4th. Furthermore, the Panel ruled #3 failed to continuously lose ground while on a break and was placed 5th.

- Inquiry #2 – Reviewed racing in the first turn between #4 Buckys Angel (Wayne Mac Lean) and #5 Fashion Frenzie (Sylvain Filion). The pan video shows #4 bears out and steps on the #5, which causes both horses to make a break. #5 wins the race; charted with an 'ix'.

- Wayne Mac Lean – 3 day driving suspension (July 5-7, 2021) – AGCO Rule 22.05.01 (h), Ruling #1243789.

- Reviewed pylons on #1 Lexus Kody (Trevor Henry) in the first turn – no violations.

- Scott Young (#2 Harry) – AGCO Rule 22.19, \$100 monetary penalty – did fail to keep both feet in the stirrups. Ruling #1243785.

Race 4 – All Clear

- #10 Bettors Authority was examined by Association Vet Dr. Julie Ballinger after the race and placed on the short-term Vet's list (lame).

Race 5 – All Clear

Race 6 – All Clear

- #6 Somewhat Sacy was a Judges Retention scratch. Refund \$1,525.

Race 7 – Reviewed pylons on #5 Stormont Barbeque (Trevor Henry) around the far turn, finished 3rd – no violations of the pylon rule.

Race 8 – All Clear

- Spoke to LP Roy (#8 Wildcat Victoria) about keeping his whip above the level of the shaft.

Race 9 – Reviewed the second quarter set by #10 Up The Creek (Jody Jamieson) – :28.1, :59.3 – 2yos making their first lifetime starts, no issues with trailing horses. Judges spoke with Jamieson, no further action needed.

Race 10 – Inquiry – Reviewed the start and break by #1 Wickenburgh (Trevor Henry). The Starting Car had #1 inside the pylons off the turn and as a result the horse jumps over a pylon and makes a break. The Judges ruled that #1 did not receive a fair start. Refund \$9,979. #1 was charted with an 'ix'.

- Judges spoke to Starter Al Dawson about the start.

- Reviewed racing in the stretch – #5 Publicity Seeker (Doug McNair) drifts and carries out #7 Logan Park (Jody Jamieson) in the stretch. #5 touches the wheel of #7, no placings needed.

Race 11 – Reviewed racing around the final turn – #9 Miami Seelster (Scott Young) was inside one pylon, no violations. Finished 4th.

- Reviewed racing in the first turn – #4 Shes Got It All (Doug McNair) was inside one pylon, ran over a pylon, and inside one pylon. No violations of the pylon rule by #4. Finished 2nd.
