Report on day's events:

Office:

- Four Ontario Sires Stakes Grassroots divisions for 3YO Filly Pacers.
- Review with Louis P Roy regarding urging in Race 3 on July 5/21 – ruling to be generated.
- Review with Ian Moore regarding an unauthorized equipment change on the horse Cadillac Bayama in Race 5 on Saturday night. Judges also spoke to Sylvain Filion and Joey Ayotte. Reserved decision.

Races:

Race 1 – Reviewed the start – #11 Amini (Sylvain Filion) suffers broken equipment (knee boot) after the start.

Race 2 – Reviewed the start between #5 Island Beach Boy (Sylvain Filion) and #6 Metallica (Jody Jamieson) – video does not support any interference and all horses ruled to have a received a fair start.

Race 3 – All Clear

Race 4 – All Clear

- Reviewed the first half fractions (:26.2, :56.1) set by #10 Shiatzu Seelster (LP Roy) – spoke to Mr. Roy; deemed not a violation of AGCO Rule 22.05.01(k).

- #9 Turning The Table finished with broken equipment (head pole).

Race 5 – All Clear

Race 6 – All Clear

Race 7 – Reviewed racing around the final turn – #1 Something Royal (Justin Turcotte) and #6 Cold Creek Lacey (Sylvain Filion) hook wheels. #4 Hannah On The Virg (Trevor Henry) was behind the two horses and suffered interference. All three horses were charted with interference. No placings needed.

- Phil Hudon (#10 Miss Rockadali) – video sent for an urging review for using more than acceptable wrist action in the stretch.

Race 8 – Inquiry – Reviewed the breaks by #6 Teddys Littleangel (Doug McNair), finished 1st, and #8 O Narutac Perfetto (Jody Jamieson), finished 3rd, in the stretch.

- #6 was ruled off gait for more than 25 consecutive strides (AGCO Rule 22.27.02). As a result, #6 finished 1st placed 9th for an extended break.
- #8 was ruled to have suffered an interference break and not in violation of the AGCO breaking rule.

Race 9 – Inquiry – Reviewed the break by #8 D Gs Magicmoment (LP Roy) before the start – not inside the Fair Start Pole, Refund \$7,217.

- #3 Jackieofalltrades was charted with an equipment break (broken outside hobble) in the stretch.

Race 10 – All Clear

Race 11 – Reviewed the performance by the even-money favourite, #6 Saulsbrook Olympia (Brett MacDonald). The horse gets away 7th and is unable to move off the rail due to the outside flow advancing in the second quarter. MacDonald gets clearance at the 3/4s and closes from seventh to finish second in the stretch. Judges were satisfied with the drive by MacDonald and no action is needed.
