## Races

Race 1 Inquiry at the start, #4 Muscle Builder made a break and was not inside the fair start pole. The horse was refunded, and the amount was \$23,992. The horse Muscle Builder did pull up and is on the Judge list and must qualify.

No video available, the horse was too far back.

Race 2 Judges will be following up with C. Christoforou about AGCO rule 22.19 "Drivers shall keep both feet in the stirrups and not make contact with the horse."

Race 3 Inquiry in the stretch. #6 Can You Swing It was off stride nearing the finish, was double lapped on and did fail to lose ground while off stride. #6 finished 2<sup>nd</sup> placed 4<sup>th</sup> for double lapped and then was placed from 4<sup>th</sup> to 6<sup>th</sup> for failing to continuously lose ground while off stride. Race 4 Unprecedented (A. Byron) did leave the course while on stride near the ¾ pole. The horse finished 7<sup>th</sup> and was placed 9<sup>th</sup> for being inside more than 3 consecutive pylons.

Race 5 Premier Nacho finished with broken equipment (knee boot).

Race 6 Reviewed the break at the start on #7 Linda's Pride (Roy), no violations.

Race 7 Reviewed the break in the stretch by #9 Century Hefner, the horse was charted with an equipment break due to a broken hopple.
