STAND

RACES

- Track and weather conditions (rain and wind) are causing slow second quarters in many races.

Race 1 – All Clear

Race 2 – All Clear

Race 3 – Inquiry – Reviewed the break by #3 Saint K (Jody Jamieson) before the start – horse was not inside the Fair Start Pole, Refund \$20,847.

- Reviewed racing in the stretch – #10 Buzz (Jonathan Drury) is visibly bearing out and tiring; no violation of AGCO Rule 22.05.01(e) by Drury.

Race 4 – #2 Thee Desperado (Phil Hudon) finished 8th placed 9th for an extended break.

Race 5 – All Clear

Race 6 – Spoke to Chris Christoforou about the performance of #6 Intothemysticmoon, who was the 6-5 second choice and finished 3rd. He stated she was gapping for the first half mile and having some steering issues being on a line. In the stretch, she was stuck behind horses and pacing all she could once she got an open lane. She closed to finish 3rd by a head. The Judges accepted Mr. Christoforou's explanation and no regulatory action is required.

Race 7 – Inquiry – Reviewed pylons on #4 Lauras Love (Bob McClure) in the stretch, finished 4th. The front tower video shows #4 races inside one pylon and does not gain an unfair advantage. No violations of the AGCO pylon rule by #4.
