#### Office:

- Program correction for TWOMACSONEMACH in the seventh race; this horse is not on the EIPH program and did not receive Lasix today.
- Program correction for SIR GALAHAD in the tenth race; the programmed driver Micheal Healy is incorrect and is not licenced while the correct driver Mike Healey is properly licenced.
- Review held with Daniel St. Pierre concerning his urging while driving ARRHYTHMOGENIC in the 10<sup>th</sup> race on 12 August. Mr. St. Pierre was adjudged guilty (second violation of the urging rules within one year) of violating AGCO rules 22.23.01(b) (excessive action) and 22.23.03(b) (more than acceptable wrist action) and assessed a monetary penalty of \$300 and five days driving suspension (18-22 August, inclusive) per Policy Directive 5-2009 (Number 1293093).

Mr. Corbeil was cautioned regarding making contact with another horse during the race being considered interference. Clear.
- 10. Discussed race pace (27 57³) with the driver of #4 ITS EDS IDEA, Ryan Guy, concerning the second quarter; the explanation of Mr. Guy was partially accepted, #4 was two lengths in front and did not impede the progress of the trailing horses; no regulatory action required. Clear.

Reviewed the break by #6 WESTERN PHIL (Marc St. Louis), the race leader, before the ½ mile pole (pulled up and did not finish), which was determined to have been caused by broken equipment (front hopple hanger); while off stride #6 did cause interference to the field (all charted with interference); #7 SANTANNA TONY suffered broken equipment (shoe) at the ½ mile pole and finished with broken equipment.
