Office:

- Early Judges scratch (injured) of BETONAWHEELIN from the second race.
- Early Vet scratch (sick) of BETTOR JET from the sixth race; this horse is entered on the short term (seven days) veterinarians list.
- Program correction in the sixth race for STONEBRIDGE ICICLE, the owner (Jean Serge Brazeau) is also the trainer.

Races:

- Reviewed the break by #3 THE BIG CHEESE (Emil Toth) before the ½ mile pole; while off stride #3 did cause interference to #4 PREMIER STAR (Benoit Hebert); no placing necessary as #3 finished sixth (last). Clear.
- 2. Reviewed the break by #4 LIVINGINTHEMOMENT (Philippe Trudeau) before the start: #4 did not have broken equipment, was beyond the fair start pole when the starter released the field and did receive a fair start. Clear.
- 3. Discussed race pace (26³ 56²) with the driver of #7 THE TWIST, Marc St. Louis; this horse was in front by at least two lengths going to the ½ mile pole then faded and finished eighth (last); no regulatory action required.
